Silver Birch (1) Request fell and stump grind as tree is very mature and will soon begin to enter decline as it approaches end of life span. Whilst the tree does not possess the greatest form (see photo for trunk curvature) the client has been happy to retain the tree to date. However, he now has concerns due to the tree's age in relation to safety of surrounding gardens should the tree or any limbs fail.  
Silver Birch (2) Already had permission cleared previously for fell and stump grind for same reasons as tree (1) above.
