Advice on principle of development and requirements for a planning application. This application follows the withdrawal of an earlier planning application (reference: V/2024/0294) which sought permission for the development of a drive-through restaurant (Use Class E/Sui Generis) with associated access, servicing, car parking, hard and soft landscaping and other associated works. Vehicular access was proposed via the unnamed carriageway to the east of the site. Following further discussions with Nottinghamshire County Council Highways Department, McDonald's has amended the scheme with vehicular access now proposed via Lane End to the north. A revised layout and updated technical assessments have been submitted.
