We have one large oak tree in our back garden which requires the following works as identified by our arborist to keep it healthy, manageable and safe and

provide sufficient clearance to our own property and neighbours garden:-

25% Crown Reduction

25% Crown Thin

Crown Clean

Crown Lift to balance the canopy

The last professional work was carried out 2011. The tree has grown, thickened and retained dead wood significantly since. Large pieces of branches and thousands of acorns are falling onto our patios roof garden and windows when we and our family and great grandchildren are in the garden and we fear for our safety. Overhanging branches reach over next doors garden where their small children play. The tree is now irregular in shape and needs re-balancing. We are both in our late seventies with health problems and cannot manage to constantly clear the deluge of acorns and leaves this large tree produces. A large branch has recently fallen in the wind and cracked a patio slab. We intend to use a professional skilled arborist who has examined the tree and will ensure that the works requested benefits the health and safety of the tree for years to come. We ensure our garden and trees are well maintained and wish this to continue.

We have photographs and a sketch plan to support our application.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
