### Description

Following the acquisition of the premises by Vision West Nottinghamshire College, and subsequent approval of multiple planning applications for the replacement of concrete cladding and installation of advertisement screens, the College now intends to further enhance the building's safety, performance, and suitability for educational use.

The proposal seeks to make the building fabric safer and more appropriate for its new function as a teaching facility. This includes the removal of the existing dilapidated and unsafe timber sliding-sash windows to the front and side elevations of the 1960s building. Surveys have rated the current windows as Condition D – a danger to health, with extensive evidence of wet rot, broken glazing, and inoperable sashes. The existing system is not compliant with current Building Regulations in relation to energy efficiency and U-values, and is therefore unsuitable for use within an educational environment.

The proposed replacement system comprises thermally broken, double-glazed aluminium windows, selected as the most appropriate solution for an education facility. This system provides:

- A durable and low-maintenance finish with a 20-year guarantee.
- Improved operability for students and staff.
- Significantly enhanced energy efficiency and thermal performance.

The new aluminium windows will also complement the modern aesthetic introduced through the recently approved cladding and advertisement screen applications.

Windows are proposed to be powder-coated in white to maintain consistency with the existing appearance and traditional sash proportions. The final colour is to be confirmed with and approved by the Local Planning Authority. 'TECHNAL Soleal 75mm' window has been specified on the drawing, but please note the manufacturer may change, but the performance specification will not.

Additionally, the proposal includes the removal of two external doors that are now surplus to requirements. These will be infilled with a brick-and-block insulated cavity wall, with the external brickwork designed to closely match the existing façade. The removal of these redundant entrances will also enhance site security, particularly in areas that have been subject to undesirable activity.
