Description of Proposed Works

Please describe the proposed works

This planning application seeks permission for the change of use and conversion of an existing double garage into a modern, high-quality beauty and body contouring business. The proposed development aims to provide specialized aesthetic services within a professionally designed and welcoming environment, catering to the local community's growing demand for such treatments.

Key Aspects of the Proposal:

Change of Use: The primary change will be from a residential garage to a commercial use (Sui Generis, or potentially Class E).

Internal Alterations: The existing garage space had undertaken an internal wall installation to create a dedicated treatment room and separate toilet facility. These alterations will be designed to meet all relevant health, safety, and accessibility standards.

External Appearance: The external appearance will be sensitively adapted and in keeping with the front facade. This has involved removal of garage door with a pedestrian entrance, vinyl frosting and appropriate small signage installed on the glass.

Services Offered: The business will offer a range of beauty and body contouring treatments, which will include non-invasive procedures such as fat reduction, skin tightening, facial treatments, and other aesthetic services. All equipment will be modern, safe, and operated by a qualified professional.

Operating Hours: Proposed operating hours will be designed to minimize impact on residential amenities, typically falling within standard business hours (e.g., Monday to Friday, 9:00 AM - 6:00 PM, with limited Saturday hours 10:00am – 1:00pm).

Parking and Access: The existing driveway will be utilized to accommodate clients. One customer will be present at once due to the nature of the treatments. Parking provision exists and that the proposal will not exacerbate on-street parking issues. Access for clients will always be clear and allowing enough turning space.

Waste Management: A comprehensive waste management plan is implemented to ensure the proper disposal of all waste generated by the business, including any specialized waste from beauty treatments, in accordance with environmental regulations.

Noise and Privacy: Due to the nature of the treatments no noise impact on neighbouring properties will be affected. Privacy for both clients and residents will be a key consideration.

This proposal represents a positive contribution to local business and provides a valuable service to the community, all while ensuring minimal impact on the existing residential character and amenities.
