Change of use of the existing dwelling at 2 Forest Road, Sutton-in-Ashfield, NG17 3BB from Use Class C3 (dwellinghouse) to Use Class C2 (children's residential care home) to provide a small, family-style home for up to 2 children (under 18) with 24-hour care. The home will be staffed by 2 care staff on a shift/rota basis (with a sleep-in arrangement overnight) and will operate as a stable, long-term placement (not a hostel, emergency provision or high-turnover facility). No extensions or external alterations are proposed; the property will remain domestic in appearance. The only minor associated works are installation of a domestic-style gated fence to allow use of the existing rear hardstanding/dropped kerb as a single off-street parking space, with the rear garden retained as amenity space.

A single off-street parking space will be provided within the rear/side curtilage using the existing dropped kerb and existing hardstanding. The only alteration is to replace the existing fence with a domestic-style gated fence to enable secure vehicular access to/from the highway. No new junctions or changes to the highway layout are proposed, and pedestrian access remains via the existing front door onto Forest Road. No new public roads or public rights of way are proposed and no diversions/extinguishments are required.

The proposal is predominantly a change of use of an existing dwelling (C3 to C2) and involves no new building footprint, excavation, groundworks, or land take. The only minor external work is the replacement of an existing boundary fence with a domestic-style gated fence to allow access to an existing dropped kerb and existing hardstanding for one parking space. The garden/vegetation will be retained, with no removal of trees, hedges or other habitats and no degradation of onsite habitat. As such, the development results in no measurable habitat loss or change, and the works are de minimis (below the threshold), so the Biodiversity Net Gain condition is not considered to apply.
