Whilst no enforcement action or breach of planning consent has been identified, the owner was asked to apply for a Lawful Development Certificate. He did this and was refused. He believes the refusal was as a result of insufficient evidence accompanying the application. The land is one of a number or parcels fronting Derby Road. It is a valued part of his efficient business and essential part of its successful operation.

This application is accompanied by further evidence which shows that the land has been in use as Storage Land for a much longer period than 10 years. Furthermore it is noted that the intensity of its operation varies from time to time as is the nature of the Storage use.
